## PUBLIC SALES

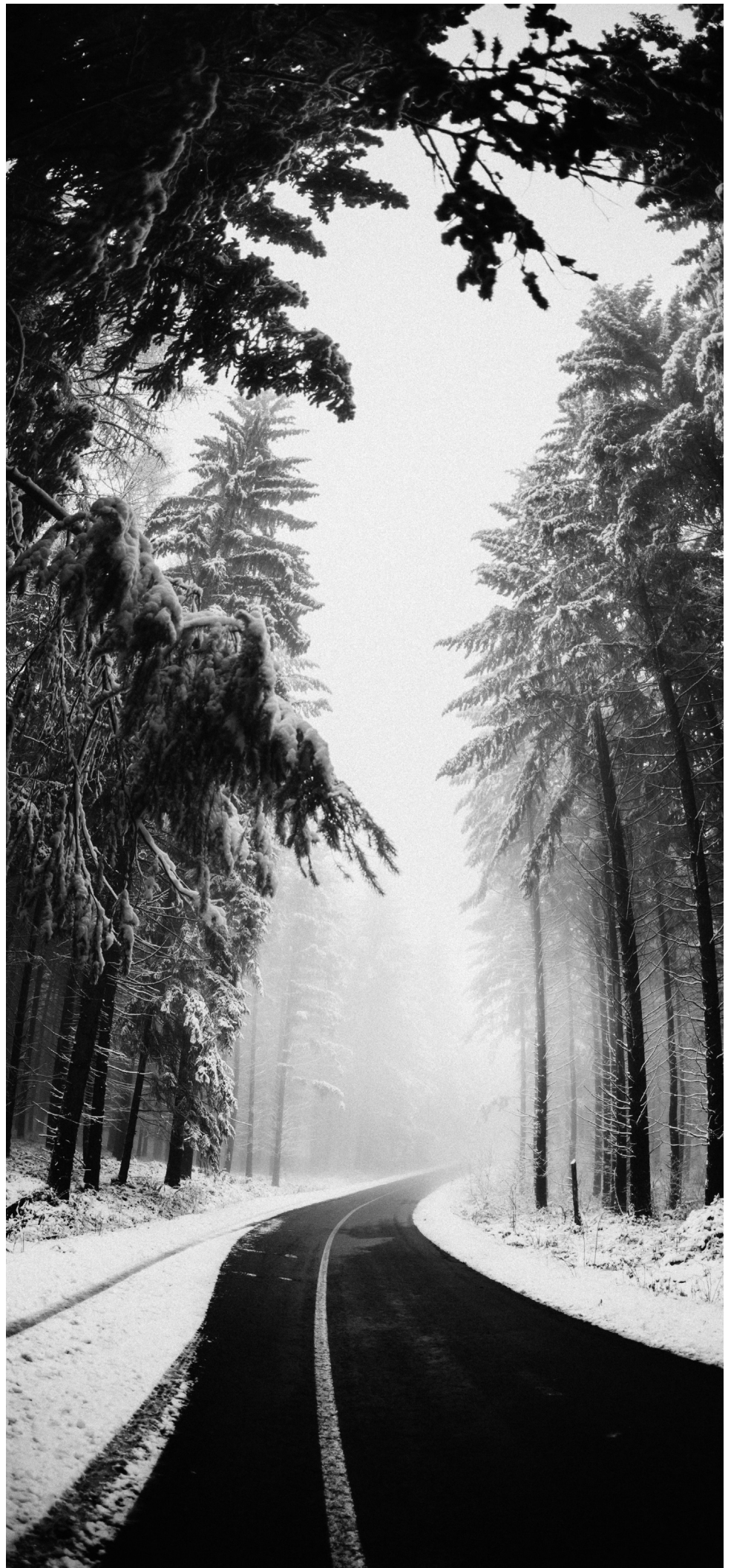
