Any person who shall violate any of the provisions of this Chapter, who shall fail to comply therewith or with any of the requirements thereof, who shall erect or alter any building or who shall commence to

erect or alter any building in violation of any detailed statement or plan submitted or approved there under, shall for each and every violation or noncompliance be deemed guilty of a misdemeanor and shall be fined not more than \$2000, and each day the violation shall be permitted to exist shall constitute a separate offense. The owner of that building or premises or part thereof where anything in violation of this Chapter shall be placed or shall exist, and any architect, builder, contractor, agent or corporation employed in connection therewith who may have assisted in the commission of any such violation shall each be guilty of a separate offense and upon conviction shall be subject to the penalties herein provided."

1. A person who violates any provision of this Chapter by performing an act prohibited or by failing to perform an act required is guilty of a misdemeanor punishable by a fine not to exceed Two Thousand Dollars and No Cents (\$2000.00). Each day the violation continues shall be a separate offense.

2. A culpable mental state is not required for the commission of an offense under this Chapter.

3. Nothing in this Chapter shall limit the remedies available to the City in seeking to enforce the provisions of this

Chapter.

4. All other legal remedies are reserved by the City if necessary to enforce the provisions of this Chapter. This shall be in addition to, and not in lieu of, the criminal penalties provided for in this Chapter.

**Section 4.** This Ordinance shall become effective from and after the date of its final passage and publication as provided by law, and it is accordingly so ordained.
